| | the Project for the benefit of Home Leasing, LLC, a New York State |
| | limited liability corporation. Due to the novel coronavirus pandemic, the public hearing today is being conducted via the Zoom video and |
| | teleconference platform in accordance with Executive Orders 202.15 and |
| | 202.87 issued by Governor Cuomo. The proposed project revitalizes six |
| | properties located on Clinton Avenue in Arbor Hill. The proposed project |
| | includes the historic preservation of four vacant row homes, the adaptive |
| | reuse of a long vacant former school building and the new construction of |
| | a three-story mixed use building into a total of 61 residential affordable |
| | housing units benefiting households with incomes up to 80% of the area |
| | medium income. Additionally the mixed use building incorporates approximately 12,000 sq. ft. of commercial space dedicated to the Albany |

| | And also with me today is Bret Garwood, our CEO. And Linda MacFarlane I think will be joining us. She's the Executive Director for |
| | ACES, our partner. I just want to thank – first off, thank the board for the |
| | opportunity to consider our application. We're very excited. This is our |
| | Phase 2 following up on our Phase 1 project which construction has |
| | wrapped up and we're working on leasing. Actually, this month, |
| | hopefully, be at 100% leased. And as Mr. Conoscenti had mentioned the |
